In 2015, the CV trawl cod and flatfish fisheries closed due to Chinook bycatch on May 3<sup>rd</sup> until an emergency rule by NMFS allocated another 1,600 Chinook to the fishery on Aug 10, 2015. Only 4 Chinook were taken in these fisheries from Aug 10 – Dec. 31.

Amendment 103 to the FMP for Groundfish became effective October of 2016. This amendment will allow NMFS to reapportion unused Chinook salmon prohibited species catch within and among specific trawl sectors of the Central and Western GOA. Effective October 12, 2016.
