# Congressional Activities Report for the Council Coordination Committee Submitted to the Caribbean Fishery Management Council

## August 31, 2016

## **Overview of Work Provided:**

- Provided information on hearings of interest to the Regional Fishery Management Councils (see below for updates on and links to House and Senate Magnuson-related hearings)
- Monitored Congressional hearings and markups related to fisheries management, international fisheries, or other issues of interest to the Regional Fishery Management Councils
- Provided notice of legislation of interest moving through the House, Senate, or to the President
- Provided Regional Fishery Management Councils' meeting schedule information to House and Senate staff for consideration in the scheduling of Congressional hearings related to the Magnuson-Stevens Act reauthorization or other fisheries issues of interest to the Councils
- Met with Congressional staff to discuss upcoming hearings and legislation
- Provided Council information to appropriate Congressional staff on fisheries issues of interest

# **Upcoming Magnuson-Stevens Act or Fisheries Related Hearings:**

No hearings have been scheduled at this time.

The House Natural Resources Committee has announced that a full committee markup will be held on September 7<sup>th</sup> & 8<sup>th</sup> (with opening statements being given on the 7<sup>th</sup> and amendments offered and votes taken on the 8<sup>th</sup>). The list of bills to be marked up has not yet been released.

## Other Upcoming Hearings or Other Items of Interest:

 Department of State will host the 2016 "Our Ocean Conference" in Washington, D.C. on September 15 to 16. According to the State Department website, the conference will focus on the key ocean issues of our time – marine protected areas, sustainable fisheries, marine pollution, and climate-related impacts on the ocean.

# **Politics, Politics, Politics:**

With the elections looming (for the White House, 1/3 of the Senate, and all of the House of Representatives), the rest of the 114<sup>th</sup> session may depend on a number of things – will the Senate remain in control of the republicans or will the democrats take control (and how big of a margin will either party have), will the House of Representatives remain in control of the republicans or could there be a larger-than-expected anti-incumbent vote giving the democrats control, and one of the biggest questions is who will win the White House.

These questions are important because control of the House and Senate in the 115<sup>th</sup> Congress may determine what happens during the remainder of the 114<sup>th</sup> Congress in November and December. If the republicans lose the White House and lose control of the Senate and the House, there will likely be a push to move a number of more controversial bills including those that would restrict the authority of the President. In addition, the current leadership is more likely to pass long-term appropriation bills (that may include riders that also restrict the authority of the President). Obviously, if the republican

leadership is on the way out at the end of the Congress, the democrats in both the House and Senate will oppose any long-term appropriation bills - especially if they contain any policy riders.

If the Senate and House remain in Republican control, there will likely not be much change in the calendar for November and December (with not many days in session after the election) and it is likely that appropriation bills will be short-term (rumors are that appropriation bill might only run through March, 2017). This is especially true if the republicans remain in control of both houses of Congress and the republican ticket wins the White House.

The amount of time the House and Senate will be in session in November and December may determine whether some bills of interest to the Councils will be finalized and sent to the President (the international fisheries package and the Dungeness crab legislation in particular).

As mentioned before, the House Subcommittee on Water, Power, and Oceans will have a new chairman regardless of the outcome of the elections. In addition, if the democrats take control of the Senate, there will be new full committee and subcommittee chairs. If the democrats take control of the House of Representatives as well, there could be a restructuring of the subcommittees at the House Natural Resources Committee and there will certainly be new full committee and subcommittee chairs. And no matter who wins the White House, there will be a fairly complete turnover of the higher-level and political staff at the executive branch agencies including the Department of Commerce, NOAA and NMFS.

Since this has been one of the strangest election years I have seen, I will refrain from making any predictions. Feel free to call me if you want to discuss politics and the elections in more detail, but in any case, my crystal ball is very foggy so I may not be able to shed any light on things.

# **Recently Introduced Legislation of Interest**:

Both the House and Senate have been out of session for the August District Work Period. No legislation can be introduced in either the House or the Senate unless that house is in session. Below are the bills that were introduced just before the August recess.

<u>H.R. 5270</u>, the "Efficient Marine Mammal Protection Act" was introduced by Congressman Russell (R-Oklahoma) on May 17, 2016 and was referred to the House Natural Resources Committee. The bill would abolish the Marine Mammal Commission and transfer its functions to the United States Fish and Wildlife Service.

H.R. 5281, the "Endangered Species Management Self-Determination Act" was introduced by Congressman Luetkemeyer (R- Missouri) on May 18, 2016. The bill was referred to the House Natural Resources Committee. Among other things, the bill would require the consent of the Governor of any state in which a listed species is found to approve the listing of that species and would require the Secretary of the Interior to submit the list of any endangered or threatened species to Congress for approval. The bill would sunset any list of endangered or threatened species every five years, requiring Congress to approve a subsequent list.

<u>H.R. 5584</u>, the "Shark Fin Trade Elimination Act of 2016" was introduced by Congressman Sablan (D-Marianas Islands) on June 24, 3016. The bill was referred to the House Natural Resources Committee

with a sequential referral to the House Foreign Affairs Committee, and the House Ways and Means Committee.

- **H.R. 5771**, the "Conserving Our Reefs and Livelihoods Act of 2016" was introduced by Congresswoman Ros-Lehtinen (R-Florida) on July 13, 2016. The bill would reauthorize the Coral Reef Conservation Act of 2000 and was referred to the House Natural Resources Committee with a sequential referral to the House Science, Space, and Technology Committee and the House Judiciary Committee.
- <u>H.R. 5775</u>, the "American Fisheries Advisory Committee Act" was introduced by Congressman Young (R-Alaska) on July 13, 2016 and was referred to the House Committee on Natural Resources. The bill is similar to S. 3087.
- <u>H.R. 5776</u>, the "Marine Mammal Research and Response Act of 2016" was introduced by Congressman Young (R-Alaska) on July 13, 2016. The bill was referred to the House Natural Resources Committee. The bill would reauthorize and amend the John H. Prescott Marine Mammal Rescue and Response Grant Program.
- H.R. 5797, the "California Seamounts and Ridges National Marine Conservation Area Designation and Management Act" was introduced by Congressman Farr (D-California) on July 14, 2016 and was referred to the House Natural Resources Committee. The bill would create the California Seamounts and Ridges National Marine Conservation Area and authorize joint management authority between the Secretary of Commerce and the Secretary of the Interior.
- **H.R. 5821**, the "Coral Reef Conservation Act Reauthorization and Enhancement Amendments of 2016" was introduced by Congresswoman Bordallo (D-Guam) on July 14, 2016. The bill would reauthorize the Coral Reef Conservation Act of 2000 and was referred to the House Natural Resources Committee with a sequential referral to the House Science, Space, and Technology Committee.
- **H.R. 5840**, the "Fishing Equipment Tax Relief Act of 2016" was introduced by Congressman Jolly (R-Florida) on July 14, 2016 and was referred to the House Committee on Ways and Means. The bill would provide a reduced excise tax for portable, electronically-aerated bait containers.
- H.R. 5912, the Department of State, Foreign Operations, and Related Programs appropriations for fiscal year 2017 Includes funding for the International Fisheries Commissions (all of the commissions are funded through one line item in the bill; however, the breakout of the commissions and the funding levels are on page 31 of the report see link below). The bill was introduced and reported by the House Appropriations Committee on July 15, 2016. - **S. 3059**, the "Marine Mammal Research and Response Act of 2016" was introduced by Senator Cantwell (D-Washington) on June 15, 2016. The bill was referred to the Senate Commerce, Science, and Transportation Committee. The bill was marked up by the Senate Commerce, Science, and Transportation Committee on June, 29 2016 (see below).
- <u>S. 3068</u>, the Department of the Interior, Environment, and Related Agencies Appropriations for fiscal <u>Year 2017</u> bill was introduced by Senator Murkowski (R-Alaska) on June 16, 2016. The bill was referred to the Senate Appropriations Committee and was marked up on June 16, 2016. The text of the bill can

The bill includes language on the mass marking of salmonids and the report notes that \$1,000,000 is provided for the Pacific Marine National Monuments.

- <u>S. 3087</u>, the "American Fisheries Advisory Committee Act" was introduced by Senator Sullivan (R-Alaska) on June 22, 2016. The bill was referred to the Senate Commerce, Science, and Transportation Committee. The bill was marked up by the Senate Commerce, Science, and Transportation Committee on June, 29 2016 (see below).
- <u>S. 3095</u>, the "Shark Fin Trade Elimination Act of 2016" was introduced by Senator Booker (D-New Jersey) on June 23, 2016. The bill was referred to the Senate Commerce, Science, and Transportation Committee.
- <u>S. 3099</u>, the "Access for Sportfishing Act of 2016" was introduced by Senator Nelson (D-Florida) on June 23, 2016. The bill was referred to the Senate Commerce, Science, and Transportation Committee. The bill was marked up by the Senate Commerce, Science, and Transportation Committee on June, 29 2016 (see below).
- <u>S. 3278</u>, the "Invasive Fish and Wildlife Prevention Act of 2016" was introduced by Senator Gillibrand (D-New York) on July 14, 2016. The bill was referred to the Senate Environment and Public Works Committee.

# **Recent Hearings, Markups, or Activities of Interest:**

- June 29, 2016 the Senate Commerce, Science and Transportation Committee marked up a number of bills including a few that could affect fisheries management, could affect operations of the Regional Fishery Management Councils, or might be of interest to the Councils. The markup can be viewed at:

    - S. 3087, the American Fisheries Advisory Committee Act, introduced by Senator Dan Sullivan (R-Alaska) and Senator Maria Cantwell (D-Washington) on June 22, 2016, would amend the Saltonstall-Kennedy Act to require the Secretary of Commerce to create an American Fisheries Advisory Committee (Committee) and establish 5 regions within the Committee. The bill would establish the number and qualifications of members to be appointed to the Committee and how they are to be appointed. The bill would establish meeting requirements, staffing authorization, and conflict-of-interest rules. The bill

would require that grants approved for funding by the Secretary of Commerce through the Saltonstall-Kennedy Act be selected by the Committee. The bill was ordered reported with a number of amendments.

- S. 3059, the Marine Mammal Research and Response Act of 2016, introduced by Senator Maria Cantwell (D-Washington) and Senator Dan Sullivan (R-Alaska) on June 15, 2016, would reauthorize and amend the John H. Prescott Marine Mammal Rescue and Response Grant Program. In addition, the bill would require the Secretary of Commerce to create a new "Marine Mammal Health Map" which would allow information on marine mammal health, strandings, entanglements, and mortality data to be publicly available. The bill was ordered reported with a number of amendments.
- S. 3099, The Access for Sportfishing Act of 2016 is to be sponsored by Senator Bill Nelson (D-Florida) and Senator Marco Rubio (R-Florida). The bill would place restrictions on the ability of the Secretary of the interior to implement restrictions on fishing in Biscayne National Park unless certain criteria are met. The bill would also amend the Magnuson-Stevens Act and the High Seas Driftnet Fishing Moratorium Protection Act to prohibit shark feeding. The bill would also make a change to the Billfish Conservation Act of 2012 and require the Secretary of Commerce to issue final regulations to implement that Act. The bill was ordered reported by voice vote (with Senators Markey and Cantwell being recorded as no votes).
- June 14<sup>th</sup> & 15<sup>th</sup>, 2016 the House Natural Resources Committee marked up a number of bills including:
  - H.R. 3094 (Cong. Graves, R-Lousiana), the "Gulf States Red Snapper Management Authority Act" which was amended and ordered reported by a roll-call vote;
  - H.R. 4245 (Cong. Pingree, D-Maine), a bill to exempt importation and exportation of sea urchins and sea cucumbers from licensing requirements under the Endangered Species Act of 1973 which was amended and ordered reported by unanimous consent; and
  - H.R. 4582 (Cong. Denham, R-California), the "Save Our Salmon Act" which was amended and ordered reported by unanimous consent.

Note: Following the adoption of the amendment offered by Chairman Bishop - which would prohibit Federal funding from being used to implement the legislation — the State of Louisiana announced that it no longer supports the legislation. Since then, the Governors of Mississippi and Texas have reiterated their support for the legislation.

• International Fisheries Package - The Senate, on May 17th, passed S. 1335, which was introduced by Senator Sullivan (R-Alaska) and had originally had been titled the North Pacific Fisheries Convention Implementation Act. In moving the bill, they changed the name of the bill to "Ensuring Access to Fisheries Act" and added both the South Pacific Fisheries Convention

Implementation Act (S.1336) and the Northwest Atlantic Fisheries Convention Amendments Act (S.1251). There are some differences between this bill and the House international fisheries package, but staff from the relevant House and Senate committees continue to meet to look at options for moving the package. The House Ways and Means Committee raised concerns with specific provisions of the bills and staff of the committees continue to work on the bill to resolve these and other concerns.

- <u>Dungeness Crab</u> The Senate Commerce, Science and Transportation Committee has now filed the report on the Dungeness crab bill (S. 1143) which could mean they have been given the okay to take the bill to the Senate Floor. We had been told previously that there was a hold on the bill – presumably in relation to the red snapper issue – but it is unclear whether this hold is still in place. - <u>National Ocean Policy</u> Northeast Regional Planning Body announced the availability of the draft Northeast Regional Ocean Plan and held a webinar to discuss the public comment process. The RPB also plans to host public meetings in each New England state in June. According to previous documents, the RPB plans to have this plan finalized by October 2016. - Marine Protected Areas The Marine Protected Area Federal Advisory Committee met May 24-26<sup>th</sup> in Maine and the meeting included a presentation on the Northeast Regional Planning Body and also a presentation by NOAA's Office of National Marine Sanctuaries on community-based nominations for sanctuaries. # Fiscal Year 2017 Appropriations – Senate Actions:

- The Senate Appropriations Committee's Subcommittee on Commerce, Justice, Science, and Related Agencies held an oversight hearing on the Department of Commerce's Fiscal Year 2017 budget request on March 3, 2016. The only witness was The Honorable Penny Pritzker, Secretary, U.S. Department of Commerce.
- The Senate Appropriations Committee reported S. 2837, the Commerce, Justice, Science, and Related Agencies Appropriations Act, Fiscal Year 2017, on April 21, 2016.    consideration of this legislation has been hampered by the gun control debate and amendments
   dealing with gun control and it is unclear when or if the Senate will return to consideration of
   the bill.

# <u>Fiscal Year 2017 Appropriations – House Actions:</u>

- The House Appropriations Committee, Subcommittee on Commerce, Justice, Science, and Related Agencies held an oversight hearing on the Department of Commerce's budget request on February 23, 2016.
- The House Appropriations Committee has marked up and reported H.R. 5393, the Departments of Commerce and Justice, Science, and Related Agencies for fiscal year 2017 on May 24, 2016.

- House consideration of this legislation is also being complicated by the potential for gun control
  amendments and it is unclear whether the House will take up the bill as a free-standing bill. It is
  likely that remaining appropriations bills, including this one, will be rolled into one or more
  continuing resolutions in September.
- The House took up and passed H.R. 5538, the Department of the Interior, Environment, and Related Agencies Appropriations Act for Fiscal Year 2017 This legislation includes provisions dealing with: the mass marking of salmon; language dealing with the implementation of biological opinions on smelt and salmonids; and restrictions on the designation of monuments in specifically-named counties. #### **Overview of Congressional Legislative Activities:**

#### Bills that have become Public Law:

• H.R. 774, the Illegal, Unreported, and Unregulated Fishing Enforcement Act of 2015. Introduced by Congresswoman Bordallo (D-Guam) on February 5, 2015. The bill was referred to the House Natural Resources Committee. The bill implements the Agreement of Port State Measures to Prevent, Deter and Eliminate Illegal, Unreported and Unregulated Fishing, implements the Antiqua Convention, amends 8 other existing international fishery agreements to impose the sanctions of the High Sea Driftnet Fishing Moratorium Protection Act, and provides additional authorities for the Secretary of Commerce to regulate IUU fishing. (The House Committee on Transportation and Infrastructure discharged the bill on July 20, 2015), passed the House on July 27, 2015, Senate Commerce, Science and Transportation discharged the bill on October 21, 2015, passed the Senate on October 21, 2015. The bill was signed by the President on November 5, 2015 and became Public Law 114-81.

• H.R. 2029, the Consolidated Appropriations Act, 2016. Introduced by Congressman Charles Dent (R-Pennsylvania) on April 24, 2015. The bill includes a number of fisheries-related provisions including an extension of State waters to 9 miles for all Gulf States for the Reef Fish FMP. The President signed the bill on December 18, 2015 and the bill became Public Law 114-113.

# Bills that have passed the House (awaiting action in the Senate):

- **H.R. 1335**, the Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act (Young, R-Alaska) Reported by the House Natural Resources Committee on September 30, 2015, passed the House on October 6, 2015.
- H.R. 2168, West Coast Dungeness Crab Management Act (Herrera Beutler, R-Washington) Reported by the House Natural Resources Committee on September 30, 2015, and passed the House on October 6, 2015. Identical legislation (S. 1143) was ordered to be reported by the Senate Commerce, Science, and Transportation Committee on November 18, 2015. I have been told that a "hold" has been placed on this legislation by Senator Rubio (R-Florida).
- H.R. 2406, the "Sportsmen's Heritage and Recreational Enhancement Act of 2015" or SHARE Act (Wittman, R-Virginia) Reported by the House Natural Resources Committee on December 10, 2015 (the bill was also referred to a number of other House Committees). On February 26, 2016, the House of Representatives passed the legislation by recorded vote. [While the House legislation does not contain fisheries provisions, there are two Senate versions of the bill (S.556, the Sportsmen's Act of 2015 and S. 659, the Bipartisan Sportsmen's Act of 2015). As reported by the Senate Environment and Public Works Committee, S. 659 includes a provision regarding the management of the Gulf of Mexico red snapper fishery.]
- <u>H.R. 3070</u>, the EEZ Clarification Act (Zeldin, R-New York) House Natural Committee's Subcommittee on Water, Power and Oceans hearing held on February 2, 2016. Ordered reported by the House Natural Resources Committee (amended) on March 16, 2016. Passed the House by voice vote on June 7, 2016.
- <u>H.R. 4582</u>, Save Our Salmon Act (Denham, R-California) House Natural Resources Committee's Subcommittee on Water, Power and Oceans hearing held on March 1, 2016. Ordered reported (amended) by the House Natural Resources Committee on June 15, 2016. Passed the House on July 5, 2016.

## Other Issues – Legislation Amending Other Statutes of Interest (as of June 30, 2016):

<u>NEPA</u> – 69 bills have been introduced that amend or cite NEPA – 12 have been agreed to in the House, 4 have been agreed to in the Senate – only 2 have become law – one dealt with a land transfer for the Albuquerque Indian School and one that authorized funds for Federal-aid highways, highway safety programs, and transit programs.

 $\underline{\text{ESA}}$  – 57 bills have been introduced to amend or that cite the Endangered Species Act – 7 have been agreed to in the House, 4 in the Senate – 1 has become law.

**MMPA** – 7 bills have been introduced – 0 have been agreed to in the House, 0 in the Senate, and 0 laws.

<u>Monuments</u> – there have been 54 bills introduced that mention monuments (only 3 mention marine monuments) – 3 have been agreed to in the House, 2 in the Senate, and 1 was passed by both the House and the Senate, but that bill was vetoed by the President (National Defense Authorization Act of 2016). The veto presumably had nothing to do with the monument language. And 1 became a law.

Antiquities Act – there has been 1 bill introduced that amends the Antiquities Act – no action.

### **Politics**:

Senator Rubio (R-Florida) – who had been a Presidential candidate and had announced he would not run for re-election to his U.S. Senate seat even if he lost the republican primary for President, after further consideration, has announced he will run for re-election to his current U.S. Senate seat.

Congressman Jolly (R-Florida) – who had announced that he was running for the U.S. Senate – has now announced he will run for re-election to his current U.S. House seat.

<u>Note:</u> According to the tentative calendar for the House of Representatives, as of August 31<sup>th</sup>, the House of Representatives has <u>17</u> days of legislative session remaining prior to the election and an estimated 16 days after the election – although it is likely that the schedule for session after the election will change. (The Senate schedule is a little harder to describe because the schedule lists days when the Senate will <u>not</u> be in session rather than the days they will be in session.)

**Note**: As of July, 2016, 52 House Members are retiring, running for other office, resigning, or have passed away and 6 Senate Members are retiring, or running for other office.

<u>Note</u>: Concerns have been raised about whether the unpopularity of one or both parties' presidential nominees might affect Senate races. While the same concern has been raised about House races as well, there are not as many toss-up seats in play for this to be a major concern. In addition, both likely presidential nominees have high negatives so turnout may be an issue for many contests including those for the U.S. House and the U.S. Senate.

<u>Note</u>: Whether control of either the House or Senate changes parties, there will be a new Subcommittee chair for the House Subcommittee on Water, Power and Oceans. The Chairman of the Senate Subcommittee on Oceans, Atmosphere, Fisheries, and Coast Guard is currently

Senator Rubio (R-Florida); however, it is unclear whether he would remain as chair in the new Congress so it is possible that both of these important chairmanships will change hands.

<u>Note</u>: Generally when a new President is elected - no matter whether there is a change in party or not – all political appointees are expected to resign and it can take up to six months or more before the new political appointees are in place and making policy decisions.

<u>Congressman Fleming</u> (R-Louisiana) – running for Senate – of interest because he is currently the chair of the Subcommittee on Water Power and Oceans.

<u>Congressman Wittman</u> (R-Virginia) – in 2017 running for governor but does not have to give up House seat – of interest because of his seat on the House Natural Resources Committee and leadership role on the Congressional Sportsmen's Caucus.

<u>Congressman Perluisi</u> (D-Puerto Rico) – is the Resident Commissioner for Puerto Rico and is a Member of the House Natural Resources Committee. He had been running for Governor; however, he lost in the primary on June 5, 2016.

- The Senate Environment and Public Works Committee marked up S. 659, the Bipartisan Sportsmen's Act of 2015 on January 20, 2016. Senator Vitter (R-Louisiana) offered two amendments related to management of the Gulf of Mexico red snapper fishery. The bill was ordered reported by a vote of 12-8.
  - The first amendment (Vitter Amendment #2) would require the Administrator of NOAA to incorporate data related to fisheries that utilize offshore infrastructure directly into stock assessments carried out for the reef fish in the Gulf of Mexico, to develop new technologies and alternative approaches to accurately assess fish populations surrounding offshore infrastructure, and to use such data for fishery management decisions in fiscal year 2016. The amendment would also require the Administrator, if an increase is made to the acceptable biological catch of the Gulf of Mexico red snapper fishery as a result of the new data required by the amendment, to allocate no less than 80 percent of that increase that is more than the historical high of 10 million pounds to the recreational sector of the fishery. The amendment would also require that the Administrator submit a report to Congress that details how new data will be incorporated and used in fiscal year 2016. The amendment was offered and withdrawn.
  - o The second amendment was modified and then offered. The amendment would extend the State boundaries to 3 marine leagues for the five States in the Gulf of Mexico for management activities pursuant to the fishery management plan for (or any amendments to) the reef fish resources of the Gulf of Mexico. The amendment passed 11-9.

At the markup, it was noted by Senator Boxer (D-California) that she had heard from Senators Nelson (D-Florida) and Cantwell (D-Washington) that management of the red snapper fishery was under the jurisdiction of the Senate Commerce, Science and Transportation Committee and that those Senators objected to the consideration of red snapper-related amendments by the Senate Environment and Public Works Committee. A hearing on the legislation had been held by the Senate Environment and Public Works Committee on March 17, 2015.
