

## Season dates and catch sharing plans

- Dates for commercial quota (IFQ/CDQ) fisheries in Alaska:
  - Open 11 March 2017
  - Close 7 Nov 2017
- NPFMC catch sharing plans accepted
  - 2C & 3A commercial and charter recreational
  - 4CDE sub-limits for 4C, 4D, and 4E




### Regulations

- Head-on landing requirement approved
  - With exception for frozen-at-sea fish
- Removal of IPHC Closed Area deferred
- Fishing in multiple regulatory areas (NMFS proposal) approved
- 2C/3A charter management measures approved
  - As recommended by NPFMC



#### Research plans

- Fishery-independent survey expansion
  - Areas 2A and 4B in 2017
  - Areas 2B and 2C in 2018
  - Areas 3A and 3B in 2019
- Five-year research plan
  - Areas of emphasis: reproduction, growth, DMR and post-release survival, migration, genetics and genomics
  - Coastwide sex-marking project



## Management strategy evaluation (MSE)

- Updating the harvest policy
  - SPR-based (coastwide fishing intensity)
  - Removing the Blue Line
    - Status quo SPR in the interim
  - Separation of coastwide fishing intensity and catch distribution
  - MSE will evaluate fishing intensity options against longterm objectives
- MSAB will soon begin to address catch distribution
