

Boardings with Safety Violations

- Most Common Violations
 - Documentation (50)
 - Visual Distress Signals (47)
 - Type IV/PFD/Life Ring (32)
 - Insufficient/Unserviceable Fire Fighting Equipment (24)
 - Insufficient/Unserviceable Immersion Suits (17)
 - Navigation Lights/Sound Signal (15)
 - Expired/Unregistered EPIRB (14)
 - Missing/Expired Life Raft (13)
 - Discharge of Oil or Sewage (2)
 - Intoxicated Operator (1)

- In 2016, 888 total federal fisheries & safety boardings
 - 104 Safety Violations detected on 129 Vessels
 - 15% of vessels boarded had safety violations
 - Decrease from 18% in 2015
 - 20 Voyage Terminations

- ➤ International Pacific Halibut Commission (IPHC)




High Seas Driftnet Enforcement

Three 2-week deployments by CG HC-130 out of Yokota, JA and Misawa, JA for MDA








Cutter Usage


Major Cutter Days




Fisheries Violations

- Non-response to CG aircraft (6)
- Significant logbook errors/No logbook (5)
- Fishing without commercial permit or permit not onboard (3)
- VMS not transmitting (1)
- Undeclared/mutilated catch (1)
- Non-CG approved boarding ladder (1)
- Failure to secure overboard discharge for boarding team (1)
- Failure to facilitate safe boarding (1)
- Retention of prohibited species (1)
- Subsistence halibut fishing without a permit (1)
- Discard of Pacific cod/Rockfish with IFQ species onboard (1)
- Anchoring in 3 NM no-entry zone (1)
- Failure to monitor VHF-FM CH16 (1)
- Failure to utilize safe release methods for halibut (1)
