Re agenda item: D-2 Crab Habitat Conservation Measures

Dear Chairman Hull and Council members:

The Kodiak Crab Alliance Cooperative (KCAC) is a co-op made up of the majority of Kodiak Tanner crab permit holders. We encourage the Council to expand the discussion paper with these items taken into consideration:

- (1) The directed Tanner crab fishery has been closed since 2014. We would like a better understanding of the effects other gear groups participating in federal groundfish fisheries are having on the Tanner crab during these times of low abundance.
- (2) In 2010 the Council recommended that PSC catch estimation be improved either by Amendment 89 or by the restructured observer program. The restructured observer program was anticipated to meet the Councils desire for more accurate and reliable catch accounting of fishing activities, including catch information for Tanner crab in the groundfish fisheries. Has this been the case?
- (3) One of the options in Amendment 89 was to have 100% observer coverage in the known areas of Tanner crab on the Eastside of Kodiak Island. The Council chose to let the restructured observer coverage pick this up, versus constraining the trawl fleet with 100% observer coverage. Can we look at the data collected over the last 7 years and say with confidence we know more now than we did in 2010?
- (4) How has the restructured observer program improved data of Tanner crab bycatch, particularity in the areas identified as critical habitat?
- (5) When the observer program came online, the Council requested NMFS to initiate a observer deployment strategy that ensures adequate coverage in the important areas (Council October 2010 newsletter). Does the deployment strategy provide adequate coverage?

KCAC looks forward to working with the Council on this very important issue. In addition to the recommendations above, we would like to see better understanding of whether or not the trawl sweeps are having the desired benefits. Our concern is the difference in the topography of Kodiak and the Bering Sea and the potential differences in the identified benefits of the sweeps as tested in the Bering Sea. In closing, please continue the discussion of this fully allocated, recovering species and continue to work with ADF&G to ensure the data collected is relevant to their needs and ability to project Tanner crab stock impacts from other users.

Dear Chairman Hull and Council members:

Koniag, Inc. is a regional Alaska Native Corporation formed under the terms of the Alaska Native Claims Settlement Act of 1971. Koniag, Inc. has approximately 3,900 Alutiiq Shareholders. Our region encompasses the Kodiak Archipelago in the Gulf of Alaska and a portion of the Alaska Peninsula. The communities in our region have been dependent on fisheries resources for subsistence and commercial purposes for centuries.

The Tanner crab populations in the Gulf of Alaska are in a period of low abundance and the directed Tanner crab fishery has been closed since 2014 to provide for the conservation of crab stocks. Prior to 2014, the Tanner crab fishery was an important source of winter fishing and income opportunity for many residents of Kodiak and the villages on Kodiak Island. This fishery was and is designed to benefit community based fishermen and to minimize the impact on crab stocks with pot limits and daylight only fishing. Being a winter fishery, the Tanner crab season was an important fishing opportunity for a fleet with limited winter fishing options and provided an opportunity for intergenerational transfer of crab fishing knowledge for communities that have not seen a commercial King crab season since the early 1980's.

Currently, Tanner crab fishermen are bearing the burden of conservation through multiple years of fishery closure while data on the impact the ground fish fisheries may have on Tanner crab stocks is lacking due to inadequate observer coverage on all ground fish gear types. Sustainable management of all fisheries depends on adequate observer coverage to minimize bycatch to the extent practicable in all fisheries.

As the Council reviews a discussion paper about central Gulf of Alaska Tanner crab conservation measures during its June, 2017 meeting, Koniag requests that you take actions to increase observer coverage in areas identified as essential fish habitat for Tanner crab around Kodiak Island to provide adequate data to understand the interactions of the ground fish fishery with Tanner crab. Furthermore, Koniag requests that the NPFMC take a precautionary approach that mitigates impacts of federal ground fish fisheries on Tanner crab stocks to address these uncertainties.
