### Movement of Halibut and Sablefish Quota Share Via Relocation and Transfer

The Council requested that staff prepare a data report showing the movement of halibut and sablefish quota share (QS) between rural Alaska communities, non-rural (urban) Alaska communities, and communities outside of Alaska (Non-Alaska). For the purpose of this report, a rural Alaska community is defined by population with a maximum cut-off at 1,500 residents. Non-Alaska communities are not distinguished by their population size. Movement of QS is denominated in pounds of individual fishing quota (IFQ) because that is the unit of the transfer market and because pounds of fish are easier to conceptualize than QS units. The regulatory areas in this report refer to the fishing area designation of the quota, not to the proximate area where a community is located.

As requested, this document provides separate reports for two modes of QS “movement.” The first mode is relocation, where a person (individual or non-individual quota holding entity) moves his or her address from one community to another. The second mode is transfer, where a person sells his or her quota to a different person who resides elsewhere. This report tracks movement within each of the three categories – AK rural, AK urban, and Non-AK – but does not include address changes or transfers that occur *within* a community. For example, transfer of QS from one AK rural community to another is included, but transfer to a different person residing in the same AK rural community is not.

This report aggregates across the years 2002 through 2016. Staff looked at year-on-year trends and did not discern any patterns of more or fewer transfers going in a given direction as time moved along. Collapsing the years simplifies an expansive data request. However, the interested reader can find full annual tables in an appendix at the end of this report.

For the following tables, “AKr” indicates AK rural, “AKu” indicates AK urban, and “Non” indicates Non-Alaska. The “>>” symbol indicates the direction of movement (from >> to). Table 1 and Table 3 show gross movement by a person relocating between the three community designations over the 2002 through 2016 time period. Table 2 and Table 4 calculate net movement into (positive) or out of (negative) a community designation category over the entire time period. Note that net movement could count a single lot of QS more than once and in more than one direction as multiple transfers could happen in the course of 15 years. For example, QS that moves from an AK rural community to an Non-AK community in 2004 and then from that Non-AK community to an AK urban community in 2010 would show up as a rural outflow, an urban inflow, and have zero net impact for the Non-AK category. The net movement tables do not consider movement from within the same community designation (AKr >> AKr, AKu >> AKu, or Non >> Non).
